BRIEF DESCRIPTION OF EACH GOVERNING BODY/OFFICE

Commission on Ministry: The primary canonical responsibility of the Commission on Ministry (COM) is to assist the Bishop in matters related to discernment and selection of persons for ministry; in the guidance and pastoral care of all candidates for Holy Orders, as well as lay professionals and other baptized persons; and in matters pertaining to lifelong learning. The Commission does this by facilitating the process for authentic individual discernment in community, by listening to the Holy Spirit and the sacred in each person, and by helping discerners grow spiritually as they identify their place in building the Kingdom of God. Members of the COM represent all orders of ministry laid out in the Catechism. Members are appointed for three-year terms by the Bishop, with terms beginning after diocesan convention. The work of our diocesan COM is done through periodic meetings as well as two in-depth retreats for those in process for holy orders. High value is placed on authenticity and integrity; listening and communication skills; intentional work focused on anti-racism skills, equity and inclusion; and compassionate understanding.

Diocesan Council: Between Diocesan Conventions, the Council oversees the budget and program goals of the Diocese, carrying out priorities adopted by Convention. Council develops a proposed budget to be ratified by the next convention. Members assume and accept the role of public relations and goodwill toward individuals and congregations facilitating connectedness within the Diocese. Members accept assignments, work on task groups, and attend regional, committee and commission meetings as necessary. Membership of the Diocesan Council is in transition through 2024, based on convention action in 2020. When complete, the Diocesan Council will include the bishop; 14 elected members (1 clergy or lay member from each of the 10 regional ministries and 4 at-large members (2 clergy and 2 lay); and up to 6 BIPOC (Black, Indigenous, and People of Color) members appointed by the bishop.

Standing Committee: The Standing Committee serves as a council of advice for the bishop and becomes the diocesan ecclesiastical authority in the bishop's absence. It makes decisions about the

sale, encumbrance or disposal of real property belonging to parishes of the Diocese. It interviews and makes recommendations to the bishop on candidates for Holy Orders, and the consent of the Standing Committee is required for ordination. The Standing Committee also gives or withholds consent to the election of bishops throughout the church and has judicial responsibilities in the case of clergy misconduct where the clergy or the complainant does not accept the adjudication of the bishop. By canon, no two members of the Standing Committee may be from the same congregation.

Secretary of the Diocese of Olympia: The Secretary of the Diocese takes part in the planning, preparation and leadership of Convention. The secretary receives (through the convention office) all resolutions, amendments, and official written business of convention. The secretary is official signatory of Convention correspondence and is an officer of the Diocese. As an officer, the secretary serves on the Board of Directors. This is a volunteer position.

Archivist and Records Manager: The archivist and records manager is the official custodian of diocesan records and is responsible for the direction and implementation of the archives and records management program of the Diocese of Olympia. This is a part-time, paid position.

Treasurer: The treasurer of the Diocese has responsibility for the assets of the Diocese, including investments, cash, and real property. The treasurer advises the bishop on financial matters, is liaison to the diocesan accounting and insurance office, and serves as an officer of the diocesan corporation. The treasurer is accountable to the bishop and the diocesan convention. The treasurer also serves as a member of the Board of Directors, the James F. Hodges Diocesan Investment Fund, the Budget and Finance Committee of Diocesan Council, and convenes the Joint Finance Panel. This is a volunteer position.

Historiographer: The historiographer is responsible for creating, maintaining and continuing a history of the Diocese, including its significant leadership and events. This is a volunteer position.

COMMISSION ON MINISTRY – LAY ORDER [three-year term]



Joel Davis – Freelance Science Journalist, St. Margaret's, Bellevue. When I was much younger and a Roman Catholic, I spent two years at St. John's Seminary College (Camarillo, CA) in studying for the Catholic priesthood. More recently at St. Margaret's Episcopal Church I served on two parish committees (one as chair) working with the Rev. Missy Couch as she progressed through her discernment and postulancy for the ordained deaconate. These experiences have given me a unique lay perspective on the role of the parish, the Commission on Ministry, and the candidate in the journey to ordination. And as a professional writer for over 40 years, I not only know how to

write well, I know how to interview and how to listen well – helpful talents for a member of the Commission.



Roberta Newell – Management (Retired), St. Mary's, Lakewood. Roberta Newell is a wife, mother who retired from State of Washington after 30 years of service. Her state service was with Employment Security Department in the executive level. She was installed into The Order of Daughters of King in the mid-90s and lives her life by the Order's Rule of Life with God's help to this day. She is currently serving as Diocesan President. She has served in the Kairos Prison Ministry International for over 20 years. She was the leader of the Washington State Kairos Torch Pilot program, servicing children whose parent are incarcerated. She is an active member of her church

Saint Mary's of Lakewood and in the Cursillo movement. She completes her term on the Standing Committee where she

served as their representative to The Commission on Ministry (COM). She enjoys traveling both domestically and international, cooking and food festivals.

COMMISSION ON MINISTRY – CLERICAL ORDER [three-year term]



Rachel Taber-Hamilton – Rector, Trinity, Everett. I am Shackan First Nation and the first known Indigenous person to be ordained in the Diocese of Olympia (2004). I have been active in Indigenous ministries in the Episcopal Church for 20 years and am the co-founder and coordinator of the independent grassroots advocacy network of people of color and allies in the diocese – Ethnic Ministries Circles of Color. My years of service in the diocese includes terms on Diocesan Council and Standing Committee (President from 2014-2017). I am currently the rector of Trinity Episcopal Church in Everett, where I have served for 11 years. I have a passion for social justice and

advocacy for people of color that informs my commitment to institutional transformation for the empowerment and equity of all people. I believe that leadership formation for ministry applies to all the Baptized and that the Commission on Ministry serves an important role in helping to identify, nurture, and form diverse leadership that reflects our Church's aspiration to be the Beloved Community and our Baptismal commitment to respect the dignity every human being.

DIOCESAN COUNCIL COLUMBIA REGIONAL MINISTRY – CLERGY [one three-year]
