### **BRIEF DESCRIPTION OF EACH GOVERNING BODY/OFFICE**

**Commission on Ministry:** The primary canonical responsibility of the Commission on Ministry (COM) is to assist the Bishop in matters related to discernment and selection of persons for ministry; in the guidance and pastoral care of all candidates for Holy Orders, as well as lay professionals and other baptized persons; and in matters pertaining to lifelong learning. The Commission does this by facilitating the process for authentic individual discernment in community, by listening to the Holy Spirit and the sacred in each person, and by helping discerners grow spiritually as they identify their place in building the Kingdom of God. Members of the COM represent all orders of ministry laid out in the Catechism. Members are appointed for three-year terms by the Bishop, with terms beginning after diocesan convention. The work of our diocesan COM is done through periodic meetings as well as two in-depth

retreats for those in process for holy orders. High value is placed on authenticity and integrity; listening and communication skills; intentional work focused on anti-racism skills, equity and inclusion; and compassionate understanding.

**Diocesan Council:** Between Diocesan Conventions, the Council oversees the budget and program goals of the Diocese, carrying out priorities adopted by Convention. Council develops a proposed budget to be ratified by the next convention. Members assume and accept the role of public relations and goodwill toward individuals and congregations facilitating connectedness within the Diocese. Members accept assignments, work on task groups, and attend regional, committee and commission meetings as necessary. Membership of the Diocesan Council is in transition through 2024, based on convention action in 2020. When complete, the Diocesan Council will include the bishop; 14 elected members (1 clergy or lay member from each of the 10 regional ministries and 4 at-large members (2 clergy and 2 lay); and up to 6 BIPOC (Black, Indigenous, and People of Color) members appointed by the bishop.

**Standing Committee:** The Standing Committee serves as a council of advice for the bishop and becomes the diocesan ecclesiastical authority in the bishop's absence. It makes decisions about the sale, encumbrance or disposal of real property belonging to parishes of the Diocese. It interviews and makes recommendations to the bishop on candidates for Holy Orders, and the consent of the Standing Committee is required for ordination. The Standing Committee also gives or withholds consent to the election of bishops throughout the church and has judicial responsibilities in the case of clergy misconduct where the clergy or the complainant does not accept the adjudication of the bishop. By canon, no two members of the Standing Committee may be from the same congregation.

**Secretary of the Diocese of Olympia:** The Secretary of the Diocese takes part in the planning, preparation and leadership of Convention. The secretary receives (through the convention office) all resolutions, amendments, and official written business of convention. The secretary is official signatory of Convention correspondence and is an officer of the Diocese. As an officer, the secretary serves on the Board of Directors. This is a volunteer position.

**Archivist and Records Manager:** The archivist and records manager is the official custodian of diocesan records and is responsible for the direction and implementation of the archives and records management program of the Diocese of Olympia. This is a part-time, paid position.

**Treasurer:** The treasurer of the Diocese has responsibility for the assets of the Diocese, including investments, cash, and real property. The treasurer advises the bishop on financial matters, is liaison to the diocesan accounting and insurance office, and serves as an officer of the diocesan corporation. The treasurer is accountable to the bishop and the diocesan convention. The treasurer also serves as a member of the Board of Directors, the James F. Hodges Diocesan Investment Fund, the Budget and Finance Committee of Diocesan Council, and convenes the Joint Finance Panel. This is a volunteer position.

### **COMMISSION ON MINISTRY – CLERICAL ORDER** [three-year term]



**Emily Austin** – Vocational Deacon, St. Mark's Cathedral & Employee Benefits Team Lead at The Partners Group, Saint Mark's Cathedral, Seattle. I remain resolutely committed to the Diocese of Olympia's future wellness as a community of worship, mutual ministry, faith formation, and sharing of the Good News. In nearly every stage of my life the Diocese of Olympia has ended up playing a role in forming my commitment to a Jesus Christ-centered life of service. I'm constantly challenged to live more deeply into my baptismal covenant here and will work, in

whatever capacity I'm called, to ensure that same thriving space for others into the future. Ordained in 2018, areas of ministry have been serving those experiencing homelessness, the sanctuary movement and immigration reform. I currently work full-time at The Partners Group, an independent professional service and employee benefits firm of 200. I was awarded the company Excellence in Customer Service award in 2022. Canonically resident in this diocese and serving at St. Andrew's, Port Angeles, I wish to work with those involved in discerning their baptismal call, whether to a deeper understanding of their call to the laity; to the priesthood; or to the diaconate. In the wounded world in which we live, the need for all four orders is more pronounced than ever but, for a variety of factors, deacons

are deeply necessary in that space between the world and the church. Like any deacon, my call is at the liminal space for deacons, but I would like to help other folks find their way to God's will.

## **DIOCESAN COUNCIL EVERGREEN REGIONAL MINISTRY – CLERGY** [one three-year]

Under my leadership, St. Dunstan's Church of the Highlands Parish, where the "Highlands" is a gated community of the wealthy, has become The Church that Feeds People. Our feeding program has run uninterrupted since 2011, delivering food every week to sanctioned tent encampments for the homeless, and feeding all who come to our doors. We have regularly hosted sanctioned homeless encampments and we now host the

Shoreline Severe Weather Emergency Shelter. We have refurbished our worship space, installed a new organ, upgraded the accessibility of our campus and paved our parking. We have transformed an old, comfortable chapel for the wealthy into a mission outpost of God's kingdom. This is not a singular accomplishment but a way of being that we, as a church, are called to.



**Nic Mather** – Rector, St. Stephen's, Longview. General Convention is a unique opportunity to come together as the larger body of our church, being in communion with one another as we listen and discern the movement of the Holy Spirit calling us Episcopalians into the gaps in our society to be an example of what it means to be Christ followers in this generation and the next. I would be honored to be elected as a part of that gathered body representing our diocese, representing smaller parishes in our diocese, and representing the more rural areas of our diocese. As a

I've worshiped and consulted with hundreds of congregations in development, conflict, clergy transitions and pastoral emergencies. Clergy Deputy #2 (2018), and as Clergy Deputy #1 (2022). At the 80th General Convention of the Episcopal Church held in Baltimore (2022), I was elected Vice President of the House of Deputies and currently serve in that role. I have a passion for social justice and advocacy for people of color that informs my commitment to institutional transformation for the empowerment and equity of all people.
