BRIEF DESCRIPTION OF EACH GOVERNING BODY/OFFICE

Commission on Ministry: The primary canonical responsibility of the Commission on Ministry (COM) is to assist the Bishop in matters related to discernment and selection of persons for ministry; in the guidance and pastoral care of all candidates for Holy Orders, as well as lay professionals and other baptized persons; and in matters pertaining to lifelong learning. The Commission does this by facilitating the process for authentic individual discernment in community, by listening to the Holy Spirit and the sacred in each person, and by helping discerners grow spiritually as they identify their place in building the Kingdom of God. Members of the COM represent all orders of ministry laid out in the Catechism. Members are appointed for three-year terms by the Bishop, with terms beginning after diocesan convention. The work of our diocesan COM is done through periodic meetings as well as two in-depth retreats for those in process for holy orders. High value is placed on authenticity and integrity; listening and communication skills; intentional work focused on anti-racism skills, equity and inclusion; and compassionate understanding.

Diocesan Council: Between Diocesan Conventions, the Council oversees the budget and program goals of the Diocese, carrying out priorities adopted by Convention. Council develops a proposed budget to be ratified by the next convention. Members assume and accept the role of public relations and goodwill toward individuals and congregations facilitating connectedness within the Diocese. Members accept assignments, work on task groups, and attend regional, committee and commission meetings as necessary. Membership of the Diocesan Council is in transition through 2024, based on convention action in 2020. When complete, the Diocesan Council will include the bishop; 14 elected members (1 clergy or

lay member from each of the 10 regional ministries and 4 at-large members (2 clergy and 2 lay); and up to 6 BIPOC (Black, Indigenous, and People of Color) members appointed by the bishop.

Standing Committee: The Standing Committee serves as a council of advice for the bishop and becomes the diocesan ecclesiastical authority in the bishop's absence. It makes decisions about the sale, encumbrance or disposal of real property belonging to parishes of the Diocese. It interviews and makes recommendations to the bishop on candidates for Holy Orders, and the consent of the Standing Committee is required for ordination. The Standing Committee also gives or withholds consent to the election of bishops throughout the church and has judicial responsibilities in the case of clergy misconduct where the clergy or the complainant does not accept the adjudication of the bishop. By canon, no two members of the Standing Committee may be from the same congregation.

Secretary of the Diocese of Olympia: The Secretary of the Diocese takes part in the planning, preparation and leadership of Convention. The secretary receives (through the convention office) all resolutions, amendments, and official written business of convention. The secretary is official signatory of Convention correspondence and is an officer of the Diocese. As an officer, the secretary serves on the Board of Directors. This is a volunteer position.

Archivist and Records Manager: The archivist and records manager is the official custodian of diocesan records and is responsible for the direction and implementation of the archives and records management program of the Diocese of Olympia. This is a part-time, paid position.

Treasurer: The treasurer of the Diocese has responsibility for the assets of the Diocese, including investments, cash, and real property. The treasurer advises the bishop on financial matters, is liaison to the diocesan accounting and insurance office, and serves as an officer of the diocesan corporation. The treasurer is accountable to the bishop and the diocesan convention. The treasurer also serves as a member of the Board of Directors, the James F. Hodges Diocesan Investment Fund, the Budget and Finance Committee of Diocesan Council, and convenes the Joint Finance Panel. This is a volunteer position.

COMMISSION ON MINISTRY – LAY [one three-year]



Tina Polf – St. Dunstan's, Shoreline; Self Employed CPA. As a woman accountant, I have lived the process of working to become a professional in an environment that did not favor women. I have mentored younger accountants. I work well within a group and am excited to be part of a process that makes sure we have the right people for the ordained ministry. I also want support those that are not called to the ordained, but rather a lay ministry. This is just as important. I am open to seeing where there are ways to improve the process, especially for those that come from

non-traditional backgrounds, including issues of institutional racism and other institutional barriers. I will use curiosity and creativity in finding ways to engage the aspirants and candidates. In my tax practice, I am very accustomed to "making taxes less scary". I welcome the idea of doing the same thing here, helping the individuals feel more confident.

DIOCESAN COUNCIL <u>BE ATTITUDES</u> REGIONAL MINISTRY – LAY [one three-year]



Jo Burkholder – St. Luke's, Seattle; Leadership Development, Kaiser Permanente. Over the course of my spiritual journey I have participated in many aspects of parish life across multiple dioceses including a constantly changing university mission church, a small parish in upstate New York with an amazing art community, a vibrant cathedral parish where I helped grow ministries to young adults, to a well-endowed parish that closed when it became clear that members were not prepared to grow, change, and engage with the evolving community. I have seen the good, the bad, the joy and the heartbreak. To that experience I bring more than 20 years of professional work

as an Anthropology and Gender Studies scholar, researcher, and education specialist. I'm trained in organizational development and equity work. As a queer parent of a transgender adult, and someone with a history of disability, I draw on the perspectives of what it can be like to feel marginal, unseen, unwelcome, and therefore skeptical.

DIOCESAN COUNCIL PENINSULA REGIONAL MINISTRY – CLERGY [one three-year term]



Eric Stelle – St. John's, Gig Harbor; Rector. When the pandemic was disrupting everything, I actually found it to be totally invigorating; taking stock of changing conditions; convening leaders to discern and articulate the core values that would anchor our decision-making; devising innovative structures and ministries to care for one another; overseeing a major capital campaign and building renovation; and doing this all with a posture of honesty and hope. Our parish flourished during those 17 months of shutdown, and we emerged as a fundamentally healthy and growing church. I want to serve the Diocese with these same skills and experience. In this season of significant

cultural shift and church decline, we must keep our eyes wide open to the legitimate institutional needs of the church, while not losing focus on our missional objective to live out the gospel with relevance and integrity on behalf of a world desperate for the good news of God with us.
