## How to Give a Gift of Stock

When giving a gift of stock, a letter of instruction (see sample below) must be sent to **three** places: Your broker, Diocese of Olympia broker D.A. Davidson, and the Diocesan Stewardship and Development Office. The letter should indicate the church, program, or ministry you wish to support.

This is a very important step that will allow us to watch for your gift and send the sale proceeds to your designated church, program, or ministry as quickly as possible! Please feel free to email this information to <u>stewardship@ecww.org</u>.

## **DIOCESAN POLICY ON SALE OF DONATED SECURITIES**

The Board of Directors of the Diocese of Olympia has adopted a policy to sell gifts of securities as soon as they are received. There may be a delay that can change the value of the stock and the gift from its value when it was donated. This may affect the amount available to the parish or program you designate.

Please follow the applicable local and federal laws for securities and taxes in conjunction with the advice of your broker and accountant. We are happy to fill in the donor information portion of any tax forms you wish to submit to us.
